ORDER OF ELECTION CANCELLATION **[ORDEN DE CANCELACIÓN DE ELECCIÓN]**

Pursuant to Section 2.053, *Texas Election Code*, the Joint Board of Hidalgo County Consolidated Water Control and Improvement District (the "District"), having convened in a public meeting, hereby ORDERS that the election of five (5) at-large directors of the District, said election having previously been ordered and scheduled to be held on Saturday, May 3, 2025, is canceled. The following candidates have been certified as unopposed and each of said candidates is hereby declared elected to the office of director for a term of either two (2) or four (4) years (to be determined by drawing lots) and shall take office upon qualification and issuance of a certificate of election in the same manner and at the same time as if the election were held on the date previously ordered:
